MINIMUM REQUIREMENTS

1. Bidders must submit the TAX compliance verification pin on a SARS letterhead. 2. In the case of the Joint venture, Tax compliance verification pins of all parties must be attached. 3. Copy of JV agreement (in case of JV) must be attached. 4. Supply municipal services (water, sanitation, rates and electricity) clearance certificate or Lease Agreement with a current Bill and rates clearances, or Current Bill of Account not owing more than 90 days. In a case where the services are paid by the Landlord, the signed lease agreement and statement of account must be submitted by the bidder. 5. All supplementary / compulsory MBD forms contained in the bid document must be completed and signed in full. 6. Failure to comply with point 5 will invalidate your bid. 7. Bidders must attach an Original BBBEE Verification Certificate or a Valid Copy of BBBEE Verification Certificate, in case of Joint Venture bidders must submit consolidated BBBEE certificate. 8. Bidders must be registered on the National Treasury Centralized Suppliers Database and must submit their registration summary report. 9. Bidders must neatly bind their bid/proposal documents. Documents must be in a book format (ring binded), indexed and page numbered (Loose documents will be disqualified). 10. Bid validity period is 120 days from the closing date.
